Solutions for space-charge-flow based on the well known axially symmetric paraxial approximation are presented. Following the trajectories and axial potentials obtained from the paraxial ray equation, representative approximate solutions are presented for the potentials within and outside the beam. These are obtained over limited regions by use of series expansions similar to those used in obtaining the paraxial approximation. The scale of the potential variations and trajectories were chosen primarily to show beam spreading in cases for which the space-charge forces are important and the beam potential is significantly depressed.
